

RETURN & REFUND POLICY

Updated at January 18th, 2026

Definitions and key terms

To help explain things as clearly as possible in this Return & Refund Policy, every time any of these terms are referenced, are strictly defined as:

- **Company:** when this policy mentions “Company,” “we,” “us,” or “our,” it refers to WillBeCEO, that is responsible for your information under this Return & Refund Policy.
- **Customer:** refers to the company, organization or person that signs up to use the WillBeCEO Service to manage the relationships with your consumers or service users.
- **Device:** any internet connected device such as a phone, tablet, computer or any other device that can be used to visit WillBeCEO and use the services.
- **Service:** refers to the service provided by WillBeCEO as described in the relative terms (if available) and on this platform.
